# **National Updates**



<u>Alternatives not quasi-policing</u> - our formal statement calling for the Northern Territory Government to retain and invest in alternative first responders that are unarmed and trained in care, de-escalation, and harm reduction.

<u>Yoorrook Justice Commission</u> the first and only truth-telling commission, designed and led by First Peoples, in Australia has handed down its final report, calling on the Victorian government to implement major reforms to redress ongoing systemic injustices, including the drastic need to reduce contact between First Nations young people and police.

In an <u>open letter</u> to Prime Minister Anthony Albanese, Walpiri Elder Ned Jampijinpa Hargraves calls for urgent action in addressing ongoing overpolicing, the criminalisation of disability, and the defunding of community-led justice initiatives.

The NSW Legislative Assembly Interim Report (2025) recommended that the NSW Government prioritise funding to Aboriginal Community Controlled Organisations (ACCOs) to support effective early intervention.

Recommendation 19 recognised the positive outcomes of ACCOs, when adequately resourced, to deliver community-based responses that police are not equipped to provide.

#### Community News

The Dharriwaa Elders Group (DEG) reported that, in Walgett, police are currently 'used as the response to all issues of public safety'. "We have witnessed first-hand the damage of a police-led response to a public health crisis and we are worse off. I know what this is doing to our young people and their future life-prospects." - DEG Elder Virginia Robinson.


